

The apparition of Edward Putnam aged about 30 years
 he testifies and saith on the 14 day of march 1672 march

 ann Putnam from and said she saw nothing but
 immediately she was blinded after that ann Putnam
 began to go to her and when she began almost to
 her still fell down blinded and had not come at her
 any more ann Putnam allse for her she put her
 hands upon the face of Joseph poepp with one the
 sabbath day at meeting and shewing her how she did it
 immediately her hands were fastned to her eyes that
 they had not be pulled from them except they had
 hand ben broken off after that ann Putnam per
 ceived if a spot at the side with a man upon it in
 geordy Gory you be a knowing of it then mercy
 lues took a stick and struck at it and then it
 went away but immediately it appeared again and
 mercy lues ofred to strike it a year but ann Putnam
 said do not if you laid your self to but presently
 mercy lues brought out with a prodigious pain in her
 arms as if one had struck her with a stick a
 pon her arms as ann Putnam told geordy Gory she
 saw her strike mercy lues with a swan wood a
 pon her arms and mercy lues an ann Putnam
 graze had with pains we were geordy Gory to be gone

and money but for the few shadow like women
 but could not discern he they were but presently found out
 in a way low narrow path of only and being asked
 which they would have how do the said they would have
 me to walk and immediately he was chafed and blinded
 her neck twisted her tooth and mouth that shut and
 gave to such seats as was put two or three men
 to it to hold her and was this in evening reason to wa
 the side by an iron hand as the set in a chair and
 two men had of it yet she was chafed moved to weild
 the side the they labored to the contrary her feet
 some farrest and I found it stayed to her feet and lifted
 with my thought together with the other two and all
 little but to prevent her from going in to the side
 with her feet farrest and this effort had toll about
 a reason of the clock in the night I have also
 seen to money witness before and since a pen on
 a field per said that hand for me near the way
 did it the prison now at the bar
